There is an agenda item to put the superintendent on administrative leave. This is not a termination. It is a relieving of job duties while continuing to receive pay. This is up for consideration.

Joe McCarthy read into the record a letter email received on March 10th @ 6:22pm. It was acknowledged in the march meeting, but it was not read into the record at that time.

### **Public Comment:**

Mari Raley requested that the board consider adding an elementary faculty member to the superintendent search. Since Mari Raley and Michelle Tillotson are both on the FAC, is there someone else in elementary who may be interested. Staff will pick someone to represent elementary.

Discussion: Jennifer corrected the motion to read May 15, 2024. Jennifer stated that her concerns about performance have been addressed.

Jordan stated this is ridiculous, she has already resigned, we will be paying 3 people to do one job, you should be ashamed of yourself,

Reggie Foster responded to Jordan's claim that we will be paying 3 people to do one job is not true.

Linda Brown is concerned that the end of the year is a very busy time for the superintendent and how everything will be completed. She is also concerned about transition. She also understands the request for administrative leave. Reggie Foster does feel that the best thing for the school is to place Jackie on administrative leave.

Joe outlined some items of concern regarding communication issues in the first few days after being sworn in that were discussed at the December board meeting. Employee Grievance in January, In February's performance review in executive session, In March a referral regarding grant compliance, and then the handling around the email received by the board on March 10, 2024. What is in the best interest of the school and the students.

Jennifer Kriegh - point of order - per robert's rules, question can not be called during debate. Joe McCarthy asked Jordan Benson to have some decorum.

Linda Brown wishes to abstain due to not having enough information, BEDF - says that the board can agree to allow her to abstain. Joe - no objection to abstaining, Jennifer Kriegh - understands that lack of information; however believes that with the information in executive session, she should be able to vote. Jordan Benson believes that she should not abstain.
